# DPP: Navigating an unknown landscape

## Digital Product Passports (DPPs):

- Are part of a **systemic transition** toward a circular economy where **collaboration is key**.
- Require **new ways of producing, sharing, and valuing data**.
- Involve **new partners** and transform existing relationships.
- Have **unpredictable impacts** on stakeholders and processes.
- Ecosystem is **complex and uncertain**.



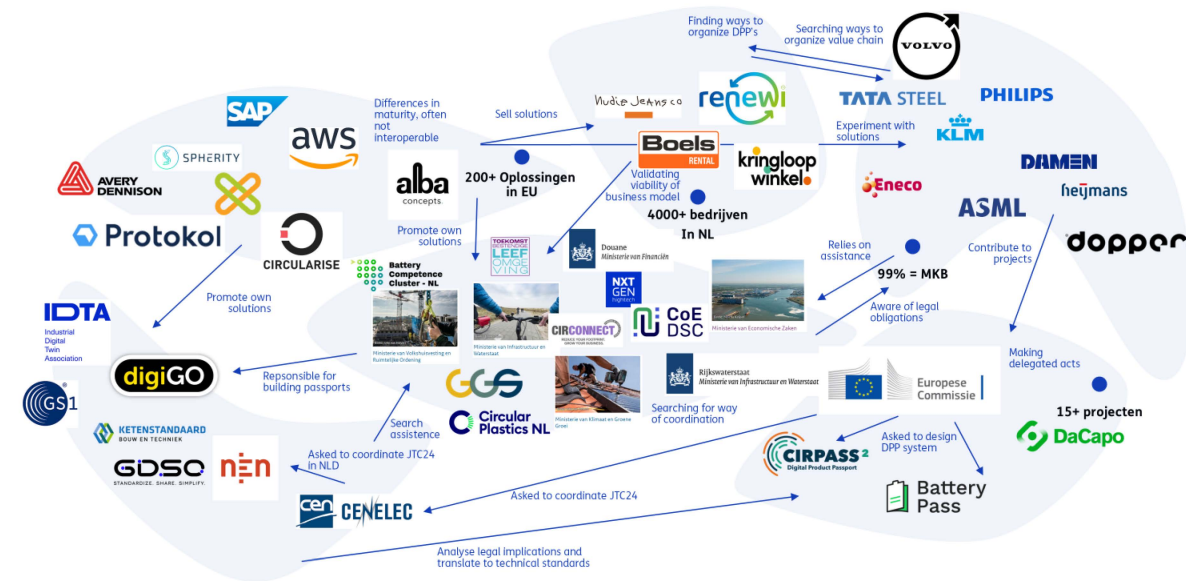
# Navigating and strengthening the DPP Ecosystem through the Landscape Scan

The DPP landscape scan maps organizations active in the Netherlands on an **ecosystem framework**.

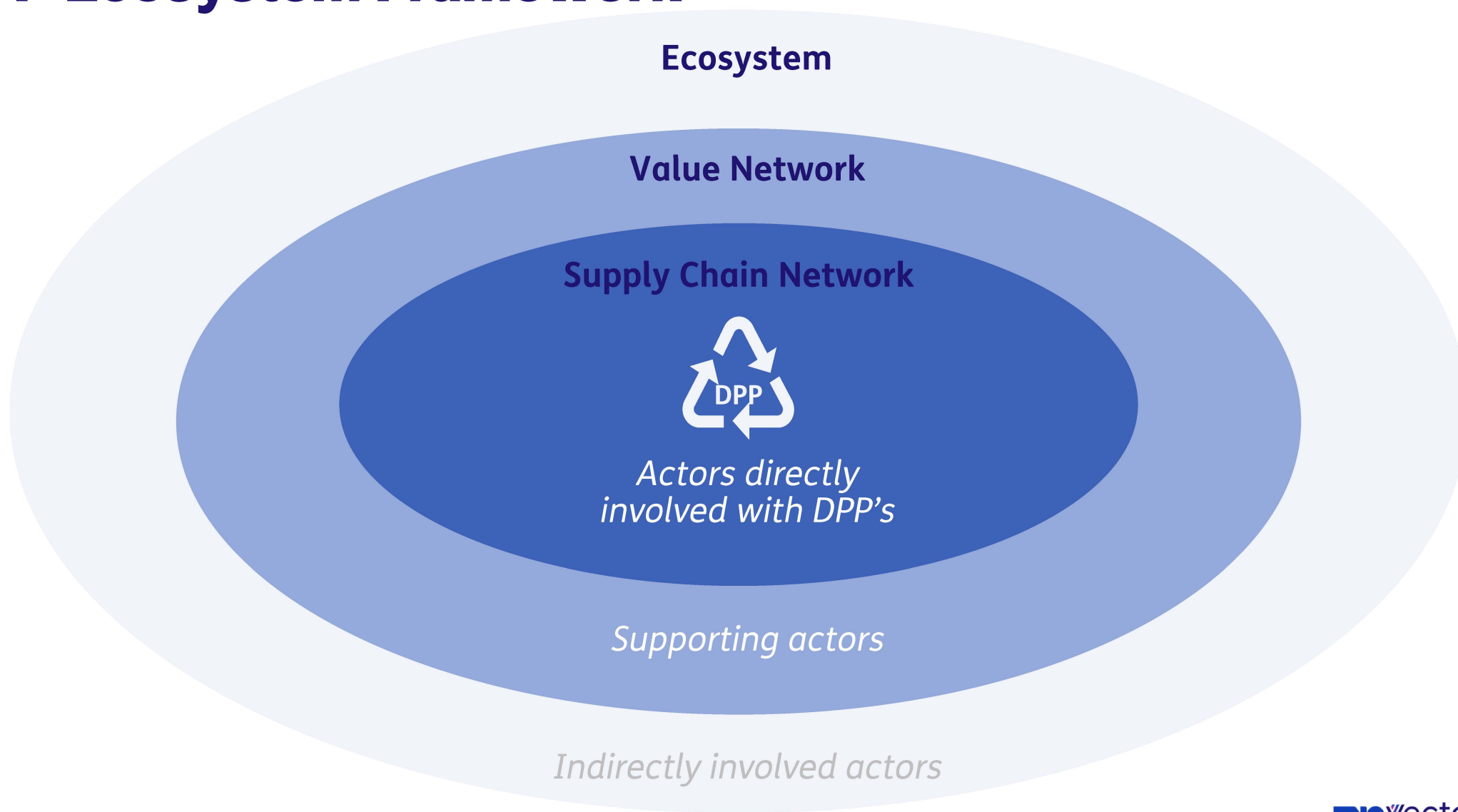
This helps organizations to:

- Create interventions to strengthen and grow the Dutch DPP ecosystem



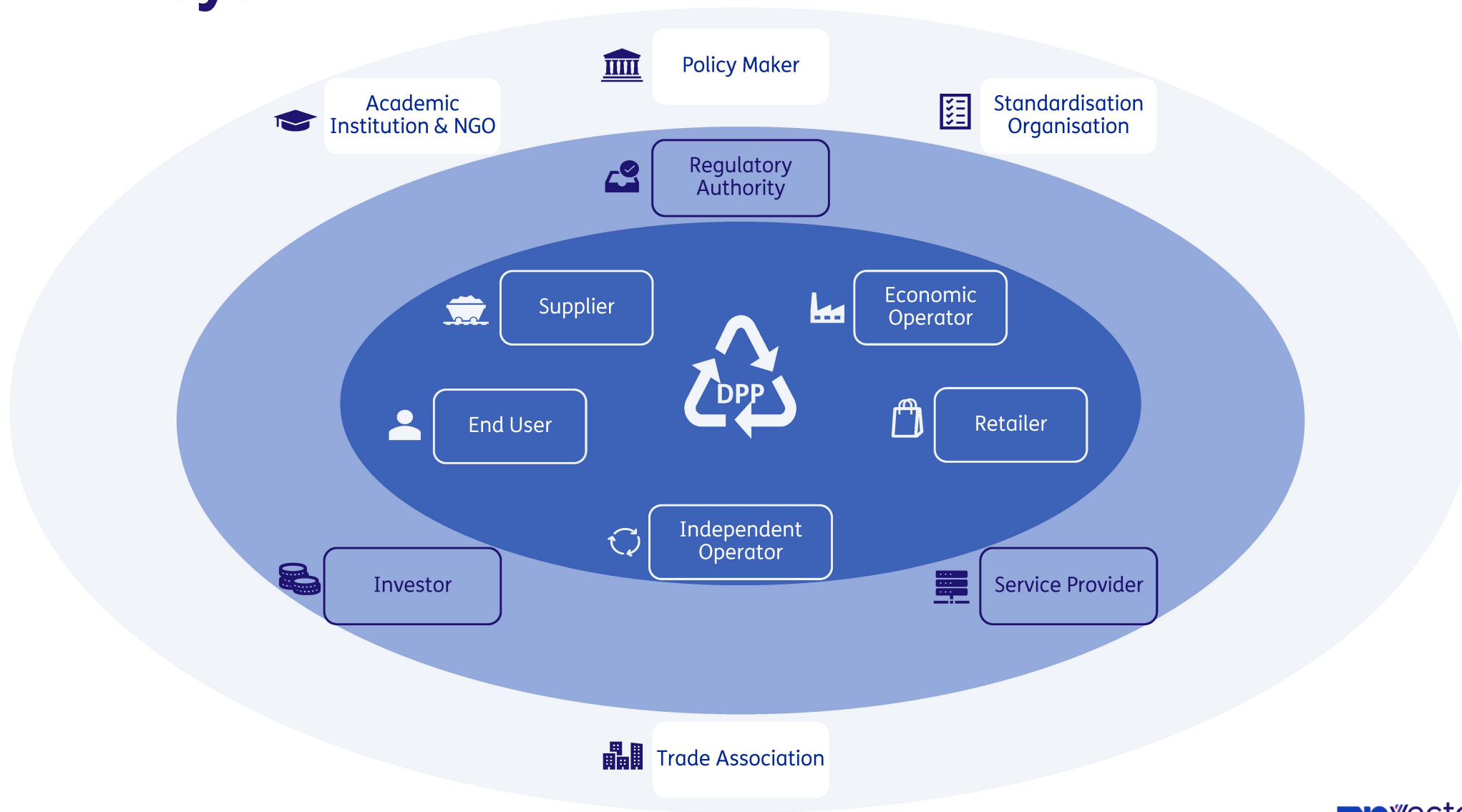


# DPP Ecosystem Framework



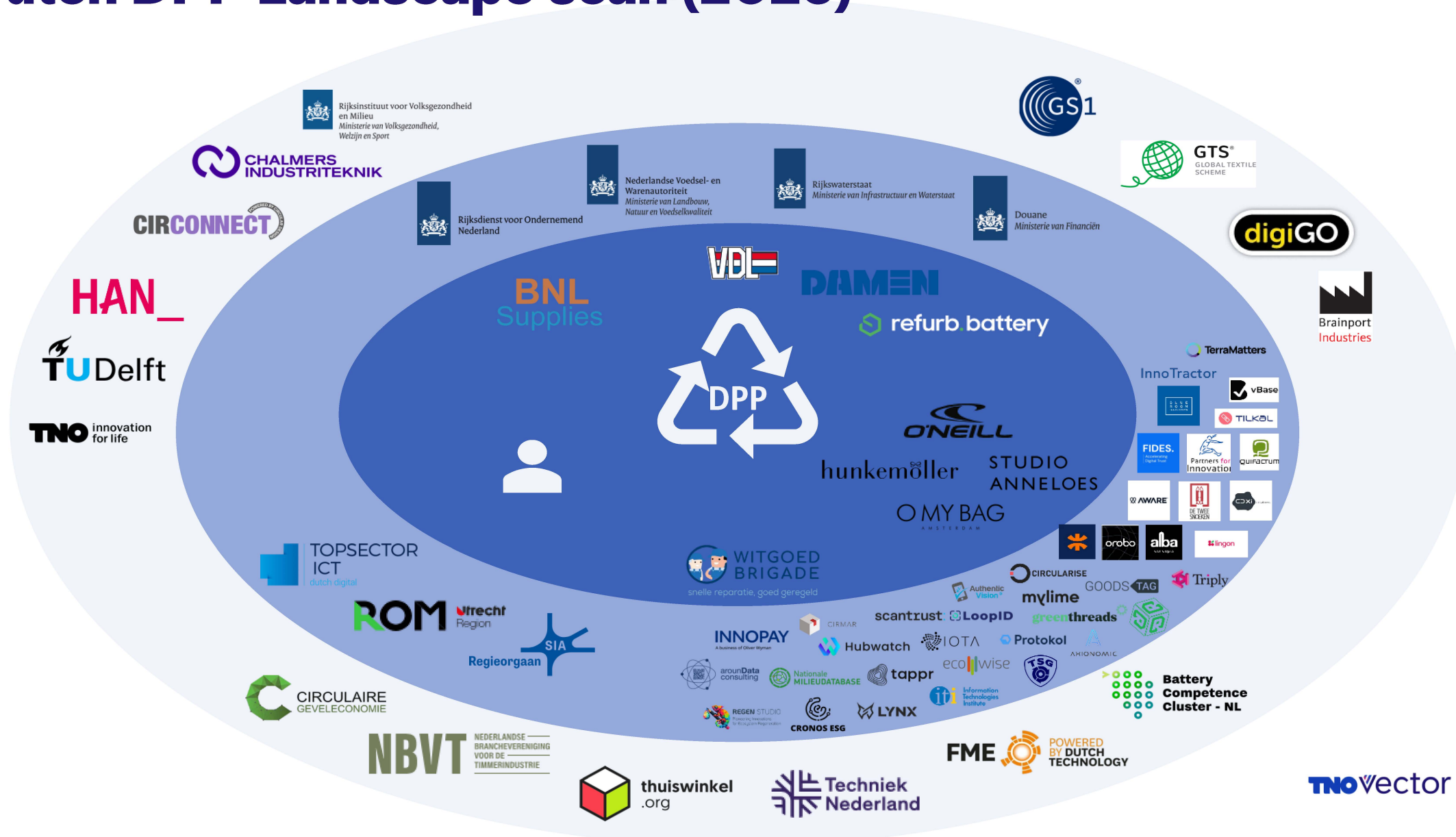

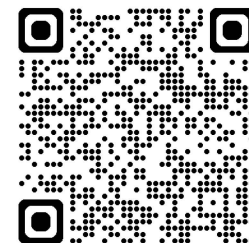

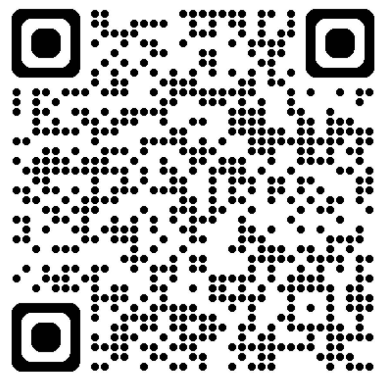
